

# CEE Commercial, Family-Sized Washer Initiative Qualifying Product List

This list based on 2011 CEE Commercial, Family-Sized Clothes Washer Specification.

## Key

- *Red italics* indicate that a product is discontinued. Discontinued models are no longer manufactured, but may still be available in the marketplace.
- *Blue italics* indicate a U.S.-only model.
- *Green italics* indicate a Canada-only model.
- Models shaded in GREY use Silver Ion
- Symbols: An asterisk (\*), plus sign (+), or pound sign (#) indicate that one or more coding variables may be used in place of the asterisks to indicate a color or feature that does not affect washer efficiency
- Models labeled "(SG)" (stacked-gas) or "(SE)" (stacked-electric) have a washer and dryer combined into one unit. CEE only requires test data for the washer and doesn't certify the efficiency of the dryer component.
- MEF=Modified Energy Factor, a combination of Energy Factor and Remaining Moisture Content. MEF measures energy consumption of the total laundry cycle (washing and drying). It indicates how many cubic feet of laundry can be washed and dried with one kWh of electricity; the higher the number, the greater the efficiency.
- WF=Water Factor (number of gallons needed for each cubic foot of laundry). A lower number indicates lower consumption and more efficient use of water.
- Although all models on the CEE list are very efficient, the tiers are structured so the most efficient products are listed in the higher tiers. For example, Tier 3 would contain the most efficient models.

## How this list is generated

Manufacturers submit energy and water use data to CEE for each model as determined by test procedures set by the U.S. Department of Energy. Models are placed in the tier appropriate to their energy and water use. CEE asks manufacturers to calculate MEF to 2 decimal places and WF to 1 decimal place, and tier eligibility is evaluated at that level of precision. CEE does not round, except when a manufacturer has submitted the data with more than 2 decimal places in the case of MEF or more than 1 decimal place in the case of WF, in which case the data is rounded to the nearest hundredth or tenth, respectively.

CEE does not verify manufacturer data with third party labs but is currently considering a change in our process. Based on the increased scrutiny by the U.S. Department of Energy and actions taken by the U.S. Environmental Protection Agency, you may wish to cross-reference the models listed below against the ENERGY STAR® qualified product list.
